



### **Medical, Assumption of Risk, and Release of Liability**

This agreement ("Agreement") is entered into as of the date set forth below by Roots Animal Sanctuary (RAS). WHEREAS the above named (guest) has voluntarily contacted RAS and has expressed an interest in working with and/or visiting animals in the care and custody of RAS. In consideration of RAS's agreement to allow the above named to view and/or interact with such animals, the above named hereby, for his/her heirs, his/her personal representatives, and him/herself represent and warrant as follows:

1. The guest is fully aware of the risks that dogs/pigs/cats/chickens/ducks/turkeys any animals on the property pose and have elected to view and/or interact with one or more animals in the care of RAS voluntarily. The guest knowingly assumes all risks that exposure to animals may pose, including but not limited to serious bodily injury and/or death.

2. THE VOLUNTEER/GUEST HEREBY WAIVES, RELEASES DISCHARGES, HOLD HARMLESS, AND PROMISES TO INDEMNIFY AND NOT TO BRING SUIT AGAINST RAS, its directors, officers, volunteers, staff, and all other agents, and attorney for any of the referenced parties and any other parties acting for or on behalf of the referenced parties from any and all rights and claims which the volunteer/guest has or which may hereafter accrue to the volunteer/guest and from any and all damages which may be sustained by the volunteer/guest directly or indirectly in connection with, or arising out of, the volunteer/guest exposure to such animals.

I agree to RAS Code of Ethics. Should I display unprofessional, dishonest, disrespectful behavior or exhibit a lack of self-discipline, at any RAS event/function, I will be asked to leave the premises/event location. As a Roots animal Sanctuary volunteer/ guest , I pledge to: Respect myself and others, keep safety in mind at all times, to communicate with staff, other volunteers and the public in a polite and professional manner, guard the welfare of all animals at all times and keep all commitments made to RAS. I agree that if alcohol is consumed, Roots Animal Sanctuary and the founders are not liable.

### **Photographic Release**

I do hereby grant and convey unto RAS all rights, title and interest into any and all photographs, images, video and audio recordings made by RAS during any activities with RAS including but not limited to any royalties, donations, proceeds or other benefits derived from such photographs or recordings. I further permit RAS to publish said images, recordings and videos at will on its website, social media sites, marketing materials and in other media for advertising and other use as RAS deems appropriate in its sole discretion.

### **Protection of Privacy Agreement**

I understand that I am a guest of RAS and I will agree to the condition of not sharing any information that could endanger the animals or humans of RAS. This includes, but not limited to, sharing of physical address to anyone not approved by RAS to receive said info, and not sharing "location" on social media.
